## COMPANY INTRODUCTION

Yester Jeans Ltd, a Hong Kong–Bangladesh Joint Venture project, is one of the best woven bottoms apparel manufacturer and exporter having its production facilities situated at EPZ, Adamjee, Dhaka. We entered into Bangladesh market as a Hong Kong–Bangladesh Joint Venture Co (Yester Accessories Co. (BD) Ltd.) in 2008 as a manufacturer of quality metal accessories and for the last 7 years this factory has well established its reputation in local garments industries and also as nominated accessories supplier to renowned brands and labels. Yester Jeans factory has been set up in the same premises in a first class brand new RCC structured industrial building having an area of over 55,000 square feet with all requisite compliant work place safety equipment's including fire fighting and its monitoring system. Initially we have installed 13 sewing lines, production capacity of about 4,50,000 pc per month having employment of over 1560 skilled workers, technicians and staffs. In about six months we will upgrade this factory to twelve sewing lines for catering to volume orders with shorter lead time. Also in house fully compliant washing plant (including ETP and SEDEX audited) will help the production and ensure on time delivery of the garments shipments. We are a registered Member of Bangladesh Export Processing Zone Authority, 'BEPZA' (vide registration #03.314.014.07.00.129.2014/248 Dated 19.03.2014, Member of Export Promotion Bureau, Bangladesh (vide registration #BD05712) and BGMEA Membership nr 5058.

## OUR STRENGTH



Buyer's satisfaction through better customer care and honoring our delivery schedules and quality commitments.

We are using computerized human resources management system based on employee's in-out through card swiping for wages and compensation/benefits calculations which is part of this computerized barcode system.



## QUALITY MONITORING



We define quality as ultimate fulfillment of customer's requirement in product, services and timeline.

We have a Quality Assurance Department which is reporting to factory ownership for independent audits and to convey true reflection of quality being produced by the factory management.

QC conduct daily random audits of cut parts during cutting process, inline audits during sewing. They also do batch audits before packing. Only QA passed garments are packed into cartons. Finished goods audits are also conducted when shipment is ready. All internal QA audits are done at AQL 1.50 . Quality Assurance Department is reporting to factory ownership for independent audits and to convey true reflection of quality being produced.





## QUALITY CONTROL

During product manufacturing, we monitor quality of raw material and final product through inspections at every step of product manufacturing.



### Fabric Inspection and QC procedures:

Incoming fabrics are inspected at JCPenney's recommended 4 point system. 100% fabrics inspected by fabric QC's. Each fault is given points keeping in view the nature and intensity of the faults. 40 points are allowed in 100 inspected yards. If number of faults/points exceed 40 per 100 yard, the fabric roll is rejected. Lab test reports are also taken from fabric suppliers and verified through internal and third party labs randomly. Shrinkage checking and washed blankets per roll are also done systematically to ensure fabric quality before bulk cutting is done

### Accessories Inspection:

Accessories at the time of receipt in store are randomly inspected by QC's/concerned persons minimum 10% of the received quantity..

### Fabric Cut Parts Inspection:

100% cut parts are inspected before allowing input to sewing line. The rejected components are replaced from remnants or balance rolls cut piece. Cut parts are also inspected 100% before sending and after receipt from printing and/or embroidery.



## Sewing Inline Inspection:

During stitching operations, the inspections are done on J C Penny's recommended 7-0 system. Inline QC inspects 7 pieces randomly for each machine operator twice a day. If he finds any fault among these 7 inspected pcs, the sewing operator has to inspect the whole bundle himself and offer inspection again to inline QC. If the inspection is fault free, then this sewing operator will undergo follow up inspection of 3 consecutive bundles. If 3 follow up inspections are ok, the inline QC moves to next machine operator. If during 1st follow up inspection, the inline QC finds any fault, then the said sewing operator has to go under 2nd follow up inspection. If the 2nd follow up fails then operator has to stop the work for a decision to be made depending on the nature of the faults (either machine will go under maintenance or sewing operator will go for training or replaced)

## Washing Plant

We have in house Washing Plant. Fully compliant with ETP and SEDEX audited. All Garments are washed at our plant.

## Washing Garments Control

Elaborate QC arrangement is available here to ensure correct wash standard. Before the washed garments are sent back to factory, our QC will pass the same and any quantity rejected will be held back at the washing plant for final inventory.

## Use of Auto Trimmer & Thread Sucking Machines:

We are using auto Trimmers for clipping to avoid un-necessary clipping cuts during this process. This is done before garments are sent to washing plant and also after coming back.

We are also using thread sucker machines to ensure the packed garments are free from loose threads.





**Final QC Inspection:**

Garments are checked 100% on quality after pressing for fabrication, finishing, appearance, sewing, shading, labeling etc to make sure that quality garments are packed into cartons.

**Measurement Specs Control:**

Before packing, garments are 100% checking on measurements for key measuring points.

**Third Party Testing:**

In addition production garments are randomly sent to third party lab (SGS, ITS, BV etc) for independent testing to make sure that the outgoing goods are meeting customer's required quality standards.





## COMPLIANCE

Yester Jeans Ltd. is a totally compliant factory duly audited and Certified by SEDEX, BSCI WRAP. ACCORD who audited our factory recently and found it's satisfactory. This report will be in Web site. We have wages and overtime calculation fully through computerized system. Employes leave records are also maintained by this system. All wages and compensation/benefits are paid in time and as per local law. Employees are hired irrespective of religion, gender, color, race, no child labor is hired (age also verified before hiring through documents and by Doctor). We have child care facility, blockage free aisles-exits-stairs, pure drinking water facility, broken needle log, worker's grievance log and needle detector m/c etc. regular fire drills are conducted and we have trained in house fire fighters. There is an elected Worker's Participatory Committee, who is responsible for the welfare and related issues of the workers.
